RE: NEW REGULATIONS AFTER THE STATE OF EMERGENCY IN NAMIBIA

1. This Circular serves to communicate the attached Public Notice, dated 26 August 2022, by the Ministry of Health and Social Services, for consideration.
2. H.E. Dr. Hage G. Geingob, President of the Republic of Namibia, announced that it was decided to remove the COVID-19 restrictions gazette under the Public and Environment Health Act of 2015, (Act No. 1 of 2015).
3. **Restriction relating to entry into Namibia:** Consequently, the negative PCR test results and a vaccination card are no longer necessary entry requirements for foreign nationals to visit Namibia.

It will be highly appreciated if Missions could familiarize themselves with the new Regulations and inform foreign travelers wishing to visit Namibia accordingly.

PUBLIC NOTICE

Clarification of entry requirements into Namibia

During the 45th COVID-19 public briefing on 14 July 2022, His Excellency the President of the Republic of Namibia announced that, given the current epidemiological situation, it was decided to remove the COVID-19 restrictions gazetted under the Public and Environmental Health Act, 2015 (Act No. 1 of 2015).

The current epidemiological situation as of today no longer supports the retention of the entry requirements into Namibia of a vaccination certificate and a negative PCR test result.

Consequently, the entry requirements into Namibia by foreign travelers of vaccination certificate and a negative PCR test result have been scrapped.
